

The NYS Department of Environmental Conservation (DEC):

- manages the majority of state recreation lands (4.9 million acres statewide)
- administers fishing and hunting licenses
- protects air and water quality and natural resources by enforcing environmental regulations and providing grant funding
- provides environmental education and outreach



DEC Accessibility Program

- **Provide guidance**, technical support, and training to DEC programs
- Engage people with disabilities in DEC programs and decision-making
- Improve access to diversify visitors to state lands
 - Accessibility assessments
 - Public information on accessible facilities
 - Respond to public inquires and coordinate accommodation requests
 - Outreach and partnerships

Fishing Access for Anglers	issue Access Passes. You can get an Access Pass and more information at the OPRHP website.

Service animals are welcome at all DEC sites. Special permits and licenses for hunting and fishing are available to people with disabilities.



- Five Beach Access Mats
- Two Wheelchair Charging Stations
- Two Mobility Devices-Beach wheelchair and Trail Scooter











Discounts for NYS Residents with Disabilities

- People with Qualifying Permanent Disabilities
 - <u>Access Pass</u> free access to most day use areas and discounted camping reservations for DEC and State Parks.
 - Free fishing licenses for individuals who are blind
 - Hunters with disabilities may qualify for <u>special permits</u>.
- Veterans with Qualifying Military Disability
 - <u>Discounted sporting license</u>- \$5 for fishing, trapping, and hunting licenses
 - <u>Lifetime Liberty Pass</u> equivalent benefits as Access Pass.





- Seniors: Sporting licenses, <u>Golden Parks Program</u>- discounted access to DEC and State Parks
- Active Duty Military: <u>Patriot Plan</u> free sporting licenses, <u>Empire Pass Patriot Plan Benefit</u>
- Every Kid in a Park- All 4th graders get in free to NYS Parks and DEC day use areas.

DEC Permits for Hunters with Disabilities

- Non-Ambulatory Hunter Permit
 - The <u>Non-Ambulatory Hunter Permit</u> allows qualified hunters to shoot a firearm from a motorized vehicle.
- Non-Ambulatory Access to State Lands
 - DEC offers designated roads for motor vehicle use by authorized individuals with a <u>Motorized Access Program for People with Disabilities</u> permit.
- Modified Longbow Authorization
 - The <u>Modified Longbow Authorization</u> allows qualified individuals to hunt with a bow equipped with a device to aid in the drawing, holding and releasing of the bowstring.
- Crossbow Accommodations
 - The <u>Modified Crossbow Permit</u> allows qualified individuals to hunt with a crossbow specifically modified to be discharged with use of a breath tube.
 - People with disabilities may request a reasonable accommodation for use of an unmodified crossbow during the regular bow season.
